Vice-Chairman Hadden ask that John Williams Road be added to Dale's list. The road needs to built up at Steephollow road to improve visibility.

The board adopted the 2015 budget.

The board reviewed road department updates

The board reviewed Sheriff Office updates.

Commissioner Boyen updated the board on the following:

The hot water heater at DFAC was leaking and had to be changed out. There was also a leak in the equipment room and their server had to be moved out. The roof needs to be inspected to see what is going on.

Mr. Jordan with EPA will come to do the final inspection for the diesel spill.
